Tuition:

Road Runners, Buckaroos, Taz Devils, Tumbleweeds and Bandits:

\$140 (April 1, 2024-March 31, 2025)

All Other Teams: \$150 (April 1, 2024-March 31, 2025)

Tuition is due the first practice of each month. It is late by the 15th. If tuition is not kept current your child will sit out until it is caught up. Tuition must be paid with cash or check. **We will not accept credit cards or Venmo for tuition.**

Fees:

Road Runners, Buckaroos, Taz Devils, Tumbleweeds, Bandits, Diamondbacks:

\$900.00

All other teams: \$1200.00

This includes:

- *2 sets of practice clothes
- * All competition entry fees
- * Music
- * Choreography
- * Competition Bow
- * Makeup
- *Athletes Banquet Ticket
- * T-shirts/sweatshirts throughout the season

Uniform: This year we will be getting a new uniform gym wide. The uniform will be \$350.00 and will be due late summer/early fall.

Road Runners, Buckaroos, Taz Devils, Bandits: Your uniform is \$225.00 and will be due late summer/early fall.

Backpacks: This is OPTIONAL and will be available a couple times of year to order. Watch GroupMe for the order form. These are approximately \$120.00

Cheer Shoes: We do not require a specific shoe however they must be all white. We don't work with any particular shoe company so you can get your shoes wherever you like.

Payment Options: Monthly tuition must be paid by cash or check only.

- 1) Pay in full: CC can be used for this option but will add a \$15 fee to the transaction.
 - a. Fees (\$1200) plus 12 months tuition ($\$150 \times 12 = \1800) \$3000 plus fee
 - b. Fees (\$900) plus 12 months tuition ($\$140 \times 12 = \1680) \$2580 plus fee
 - c. Diamondbacks (\$900) plus 12 months tuition ($\$150 \times 12 = \1800) \$2700 plus fee.

If you made your deposit it will be deducted from the PIF amount.
If you have more than one child on team please see Lynae for your PIF amount.
- 2) \$1200 fees split \$600 due in April and \$600 due in August. Monthly tuition (\$150) paid each month.
- 3) \$900 fees split \$450 due in April and \$450 due in August. (tuition pd each month)
- 4) \$1200 fees split between 4 months (\$300 due May, July, Sept and Nov)
For this option you must leave a credit card on file for me to run the 4 payments. Please fill out the attached Credit Card Authorization form and return with packet. A \$5 fee will be added to each transaction.

Payments will be run between the 1st and 5th of the above months depending on what day of the week the 1st falls on. This option is not available for the \$900 fees.

Please fill out and return the attached program agreement. If you plan on doing option 3 for your payment plan, please return the credit card authorization form as well.

Cheers All Star (Rec) Competition Team Rules

Cheers All Star membership is a privilege. We expect our athletes and parents to uphold the highest standards in the gym, at competition and in the community.

*Joining a team is a 12 month commitment: April 1, 2024-March 31, 2025

*Whoever signs the release is financially responsible for the entire year. While we are understanding to divorce households, we will not be responsible for collecting payments from one parent or the other. That should be decided between the two parties and handled on your own.

*If your athlete quits for any reason, you forfeit all fees. No refund will be given and you will be assessed a \$500 quitters fee. You will also not be allowed to join a tumbling class, do privates or be on a team at Cheers again.

*NO payment arrangements will be accepted other than the options given in the packet. Do not ask Lynae for special arrangements.

PARENT EXPECTATIONS AND RULES

- *Keep up with financial obligations. If you fall behind on tuition or fees you will not be allowed to purchase extra or optional items. Tuition and fees come first.
- *Refrain from negative gossip or creating drama in the gym or at an event.
- *Refrain from talking about other children, parents or coaches in a derogatory way. You never know who is sitting around you and can hear your conversation.
- *We allow parents to watch the first 2 weeks of each month (sometimes circumstances force us to change this) and we close viewing the last 2 weeks of each month. Please do not coach from the sidelines. Please trust your coaches.
- *Siblings are welcome to watch during viewing weeks but are not allowed to run, tumble, play in the pit or on the trampoline.

ATHLETE EXPECTATIONS AND RULES

- *#1 Expectation is to have fun and enjoy being here
- *#2-ATTENDANCE! It is VITAL that you are at practice. You typically only practice 6 days a month. We cannot have an effective practice if you are not here.
- *Never use alcohol or drugs, including vaping
- *Never challenge the authority of a coach or team parent
- *Read, sign and FOLLOW the social media agreement
- *Wear the correct practice clothes and bow
- *Cell phones should be put away for practice.

ABSENT POLICY

- *If you are missing practice an email MUST be sent to: cheersabsentrequest@gmail.com

*Please do not post the absence on groupme or text Lynae. The coaches keep up with the absences and they can more effectively plan practice when they know who will be missing.

THIS "WAIVER OF LIABILITY, INDEMNIFICATION, ASSUMPTION OF THE RISK, AUTHORIZATION TO CONTACT EMERGENCY MEDICAL ASSISTANCE and PHOTO AND VIDEO RELEASE FORM" ("Form") HAS BEEN APPROVED BY REDLINE CHEER & DANCE COMPANY, L.L.C., a Texas limited liability company ("Redline"), for use at all events held by its members. If you are over the age of 18, you are releasing legal rights for yourself by initiating and executing this form. READ IT CAREFULLY. If the participant is under the age of 18, as a parent or legal guardian you are releasing rights for yourself and for your child by initiating and executing this form. READ IT CAREFULLY. Please review the form carefully, and initial the beginning of each paragraph in the spaces provided before completing the information on the lines provided.

A. [Initial] As an individual over the age of 18 or as the parent or legal guardian of the above-listed child, I freely acknowledge that I have or will voluntarily register (myself/my child) to participate in cheerleading and dance activities held/sponsored by Redline, which include dance, gymnastics, stunting, jumping, and tumbling components. I acknowledge that (my/my child's) participation in cheerleading and dance activities entails both known and unanticipated risks that could result in serious and permanent physical and emotional injuries to (me/my child), (my/my child's) death, damage to property, and injury to others. I also acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that (I/my child) may be exposed to and infected by COVID-19 while participating in cheerleading and dance activities. I understand that such risks are inherent in these activities and that even with precautions and safety measures they cannot be eliminated without jeopardizing the essential qualities of the activities. I also understand and acknowledge that injuries (I/my child) receive(s) may be compounded or increased by negligent rescue operations and as such, I understand that other than telephoning for an ambulance, no medical assistance shall be provided by Redline, its agents, staff or other representatives in the event an injury occurs during the event. Understanding such dangers, I hereby knowingly and voluntarily enroll (myself/my child) in events held/sponsored by Redline. I give my consent for (me/my child) to engage in the dangerous activities described above, and I assume the risk of the activities involving myself/my child. I understand that (I do not/my child does not) have permission to participate in cheerleading and dance activities at an event held/sponsored by Redline without agreeing to the terms and conditions on this release. I understand that this Form is effective for all events held/sponsored by Redline for a twelve-month period from date of signature ("effective period"). I understand that this release and waiver of liability shall continue to be in effect during the above stated effective period until such time as I renounce it, in writing, at which time (I/my child) shall no longer be able to participate in any event held/sponsored by Redline.

B. [Initial] I represent that (I am/my child is) in good health and that no condition of (mine/my child's) would constrain (me/my child) from safely participating in or would compromise the safety of others from participating in the activities described in paragraph A. I understand that failure to provide information of any health condition that would constrain (me/my child) from participating could result in serious injuries or death to (me/my child). I certify that I have adequate insurance to cover any injury or damage that (I/my child) may suffer while participating in an event held/sponsored by Redline. I agree to bear the costs of any injury or damages (I/my child) may suffer while participating in any event held/sponsored by Redline. I hereby authorize Redline or representatives of Redline to call for medical care for (me/my child) if in the opinion of such personnel or (my/my child's) coach medical attention is needed.

C. [Initial] On behalf of (myself/my child and myself), I hereby knowingly and voluntarily release and forever discharge Redline and all its employees, agents, coaches, instructors, assistants, officers, managers, directors, owners, members, subcontractors, and any other representative or affiliates and their respective heirs, successors, and assigns (collectively with Redline, "Redline Representatives") from any and all liability arising out of or in connection with the above-described activities involving (myself/my child) at any and every event held/sponsored by Redline. "Liability" means any and all claims, demands, losses, causes of action, lawsuits or judgments of any and every kind that occurs during or incidental to the above-described activities, that result from any cause whether caused by the negligence, gross negligence, or otherwise.

D. [Initial] I hereby agree to and shall indemnify, defend, save and hold harmless Redline Representatives from and against any and all loss, liability, damage, or cost they may incur, including attorneys' fees and litigation costs, arising out of or related to the above-described activities, whether caused by negligence, gross negligence, or otherwise.

E. [Initial] I hereby agree that the assumption of risk, the release and waiver of liability, and the indemnity agreements contained herein extend to all acts of negligence and gross negligence and is intended to be as broad and inclusive as is permitted by the law of and any other state whose laws apply to the activities, and that if any portion of this Form is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
